**8<sup>th</sup> GRADE INCENTIVE GRANT**  
**REVENUE ALLOCATION PLAN (RAP) GUIDELINES**

**PURPOSE OF PROGRAM:**

To provide for the education needs of the Sac and Fox Nation's school-aged children and youth. Native American children and youth historically and continue to have a higher rate of drop-outs which impacts on their ability to attend institutes of higher learning. It is important for school-aged children and youth to know there is a community which supports their activities and supports their education goals. Children are the future of the Sac and Fox Nation and it is vital to foster an atmosphere that encourages all children and youth to strive to obtain an education. All Sac and Fox Nation tribal members who have successfully completed the 8<sup>th</sup> grade may participate in this program.

**GUIDELINES:**

1. Students must submit a **completed 8<sup>th</sup> Grade Graduation Application** and return the application to the Sac and Fox Nation's Education office within 60 days of graduation.
2. Students must submit a tribal enrollment card (CDIB) as verification of membership in the Sac and Fox Nation.
3. Students must provide verification of having graduation from the 8<sup>th</sup> grade by August 30<sup>th</sup> of the graduation year. Verification must be on the school's letterhead from the **principal, counselor, or teacher** (only if homeschooled) stating the student has graduated with the requisite number of credits and has met the state graduation requirements.
4. Students must sign and submit the Privacy Statement as part of the application.
5. Each fully completed application submitted by a qualified Sac and Fox student will receive \$100. The program has limited funding; therefore, the program will fund as many students as funding permits. **Note: Funds are available on a first-come, first-serve basis and does require that all of the above are included with the submitted application.**

**PURPOSE OF PROGRAM:**

To provide for the education needs of Sac and Fox Nation school-aged children and youth. Native American children and youth have historically and continue to have a higher drop-out rate; thereby preventing them from seeking a higher education degree. It is important for school-aged children and youth to know that there is a community which supports their activities and their education goals. Children are the future of the Sac and Fox Nation and it is vital to foster an atmosphere that encourages all children and youth to strive for excellence by achieving a higher education. All Sac and Fox Nation tribal members who have successfully completed the 12<sup>th</sup> grade may participate in this program.

**GUIDELINES:**

1. Students must submit a completed 12<sup>th</sup> Grade Graduation Application with all the required information and return the application to the Sac and Fox Nation's Education Department. **Incomplete applications will not be processed.**
2. Students must submit a tribal enrollment card (CDIB) as verification of membership in the Sac and Fox Nation.
3. Students must provide verification of having graduated from the 12<sup>th</sup> grade within sixty (60) days of graduation. Verification must be on the school's letterhead and signed by the **principal, counselor, or teacher** (only if homeschooled) stating that the student has graduated with the requisite number of credits and has met the state graduation requirements.
4. Students must sign and submit the Privacy Statement as part of the application.
5. Students dually-enrolled in high school and college and/or vocational technical school **shall not qualify for both high school and college/vocational technical school incentives in the same academic year.**
6. Each completed application from a qualified Sac and Fox student will be reviewed in the order in which it was received. Each eligible student will receive \$200; dependent upon the availability of funds. **Note: Funds are available on a first-come, first-serve basis and does require that the application is fully completed and the required attachments are included.**

**GENERAL EDUCATION DEVELOPMENT (GED) INCENTIVE**  
(12/21/15)

**PURPOSE OF PROGRAM:**

To provide for the education needs of the Sac and Fox Nation's members who did not complete high school and have taken it upon themselves to obtain their General Education Development (GED). Native American children and youth historically and continue to have a higher rate of drop-outs; therefore, a lesser chance of attending institutes of higher education. High school drop-outs have a severe disadvantage in gaining any type of meaningful employment and many individuals try to correct this situation by obtaining their GED. It is important for tribal members to obtain their GED in order to make a better life for themselves and to know there is a community which supports their activities and supports their education goals. It is vital to foster an atmosphere that encourages all tribal members to educate themselves and to strive for excellence. All Sac and Fox Nation tribal members who have successfully completed a GED program may participate in this program.

**GUIDELINES:**

1. Students must complete the GED Graduation application with all required information and submit the application to the Sac and Fox Nation's Education office. **Incomplete applications will not be processed.**
2. Students must submit a tribal enrollment card (CDIB) as verification of membership in the Sac and Fox Nation.
3. Students must provide a copy of the GED certificate as proof of successful completion of the GED requirements.
4. All applications for this program must be received successful **within sixty (60) days of the student's completion of a GED program.**
5. Students must sign and submit the Privacy Statement as part of the application.
6. Students dually-enrolled in a GED program and college and/or vocational technical school **shall not** qualify for both the GED and college/vocational technical school incentives in the same academic year.
7. Each completed application from a qualified Sac and Fox student will be reviewed in the order in which it was received. Each eligible student will receive \$200 and the program will fund as many students as funding permits.

**DEGREE/CERTIFICATION INCENTIVE**

**PURPOSE OF PROGRAM:** To provide for the continuing education needs of the Sac and Fox Nation's tribal members who have completed a post-secondary degree or certification program. Native Americans historically and continue to have a higher rate of drop-outs which impacts their ability to attend institutes of higher education. It is important for tribal members to know that there is a community which supports their activities and their desire to obtain a higher education. In order for the Sac and Fox Nation to continue to grow, we must foster an atmosphere that encourages all tribal members to strive to obtain an education. It is only through this generation and that of future generations of students that we will be able to sustain ourselves as a viable tribe – education is the key to our future!

All Sac and Fox Nation tribal members who have successfully completed a post-secondary degree or adult vocational training certification may participate in this program. Incentives are provided for the completion of only one Associate's degree, one Bachelor's degree, one Master's degree, and one Doctoral degree per tribal member and will provide a one-time only incentive upon proof of graduation from an accredited vocational technical school per tribal member.

**GUIDELINES:**

- Students must complete the Education Incentive Application and provide all required information/documentation and submit the application to the Sac and Fox Nation's Education Department. **Incomplete applications will not be processed.**
- Students must submit a tribal enrollment card (CDIB) as verification of membership in the Sac and Fox Nation.
- Students must provide verification of having graduated with a degree or certification within (60) days of the graduation date. Verification must be in the form of an official school transcript or other notification provided by the school.
- Submit a signed copy of the Privacy Statement with the application.
- Adult vocational training certifications must be for programs which have a **duration of nine (9) months or longer.**
- Each completed application from a qualified Sac and Fox student will receive \$1000.00 for obtaining a post-secondary degree or \$750.00 for obtaining a certification from an adult vocational training program. **Funding is limited and is on a first-come, first-served basis but we will fund as many students as possible.**

## PRIVACY STATEMENT
