Bids will be opened and publicly read aloud at 10:00 A.M. on October 28, 2016 in the Learning Center of the Sac & Fox Nation Tribal Complex, 920833 S Hwy 99, Bldg A, Stroud, OK 74079; located 5 1/2 miles south of Stroud on SH 99.
