2. Recite and sign the Sac and Fox Nation Tribal Court Oath;
3. Consent to jurisdiction of the Sac and Fox Nation Tribal Courts; and
4. Sign the Sac and Fox Nation Tribal Court Roster of Licensed Attorneys.
